## **JSH Engineering Solutions CC COC Account Agreement**

1. The Applicant hereby warrants that the above information is true and correct in each and every respect and may be relied upon, and undertake to notify the CC in writing of any change of details shown above.
2. We/ I hereby consent and give permission that the CC may at any time check our company or ourselves at any Credit Bureau or Bank as and when required.
3. The applicant agrees to pay any legal charges incurred in collecting any outstanding debt which may occur as a result of any default in any payment due by the Applicant to the CC.
4. The applicant consents to the jurisdiction of the Magistrate's Court in terms of the provision of Section 45 of the Magistrate's Court Act (32 of 1944 as amended), for the determination of any claim which the Company may at any time have against the Applicant, even though the amount of the claim exceeds the jurisdiction of such Court.
5. The Applicant warrants that as at this date it has not ceded its book debts to any person or Company, save specifically set forth hereunder and undertakes not to do so prior to giving the CC 14 (fourteen) days notice thereof and than only with the CC's consent.
6. I, by my signature, do here to bind myself in my private capacity as surety for and co-principal debtor in solidum with the Applicant in favour of the CC for the due performance of any obligation of the Applicant, and for the payment to the CC by the Applicant of any amounts which may at any time become owing to the CC by the Applicant for whatsoever cause arising and including, but without limiting the generality of a foregoing, any claims for damages and actions against the Applicant acquired by way of cession. This suretyship shall be a continuing covering guarantee / surety which may only be cancelled in writing, by the CC, and then only, provided that all sums then owing by the Applicant (whether due or not) to the CC have been paid in full. I hereby renounce the benefits of the legal exceptions "Non Causa debiti" and "Cession of Action", with the force, meaning and effect of which I declare myself to be fully acquainted.
7. The Applicant hereby acknowledges, irrevocably, indemnifying both the CC and Total South Africa (Pty) Ltd against any claims, costs and expenses of whatsoever nature suffered or incurred by them, directly or indirectly, as a result of any transaction under this Agreement.
